ORDER:

The Principal, K.S.R. Institute of Dental Science and Research, Tiruchegode has applied to this University enclosing the Essentiality Certificate obtained from the Government of Tamil Nadu and filled in application form for Letter of Consent of Affiliation for increasing of intake from 60 to 100 seats in B.D.S. Degree Course from the Academic Year 2012 – 2013.

Based on the Essentiality Certificate issued by the Government of Tamil Nadu and on the request of the institution, this University had constituted an Inspection Commission to inspect and to verify the infrastructural facilities available at K.S.R. Institute of Dental Science and Research, Tiruchegode for increase of seats from 60 to 100 in B.D.S. Institute of Dental Science and Research, Tiruchegode for increase of seats in BDS degree course from 60 to 100 vide letter No. Affln. IV(3)/01133/2011, dated 15/09/2011. The Governing Council in its meeting held on 27/09/2011 ratified the action of the University for having issued Letter of Consent of Affiliation for BDS Degree course.

The Government of India, New Delhi in their Letter No. F.No.V. 12017/76/2011-DE, dated 13/07/2012 conveyed the approval of the Central Government for increase of seats in BDS Course from 60 to 100 from the academic year 2012 -2013 at K.S.R.

Institute of Dental Science and Research, Tiruchegode.

On the request of the Institution this University had constituted an inspection commission to inspect and verify the infrastructural and teaching faculities available at K.S.R. Institute of Dental Science and Research, Tiruchegode for considering issue of Provisional Affiliation to the Institution. The inspection commission had inspected on 17/08/2012 and submitted the report to this University.

ANNEXURE

- 1. K.S.R. Institute of Dental Science and Research, Trichengode shall abide by the provisions of the Tamil Nadu Dr. M.G.R. Medical University Act, 1987 (Tamil Nadu Act 37 of 1987) and by Statutes, Ordinances, Regulations and Rules of the Tamil Nadu Dr. M.G.R. Medical University applicable to the Dental College framed from time to time.
- 2. The Dental College shall agree for the inspection of the college by the Tamil Nadu Dr. M.G.R. Medical University at any time according to the Statutes, Ordinances, Regulations and Rules for medical colleges framed from time to time.
- 3. The Dental College shall abide by the Statutes, Ordinances, Regulations and Rules framed by the Tamil Nadu Dr. M.G.R. Medical University on matters of syllabus examinations code of conduct, curricular activities, etc., framed from time to time.
- 4. The conditions that may be prescribed by Dental Council of India shall be fulfilled. The standard of requirement prescribed by Dental Council of India from time to time for admission to Dental College shall be followed strictly.
- 5. Only qualified staff shall be appointed to handle the classes.
- 6. No unqualified staff shall be appointed.
- 7. Only eligible candidates according to the regulations of this University shall be admitted to the I B.D.S. Degree Course.
- 8. While making admission, the rule of reservation of the Government of Tamil Nadu shall be adopted strictly.
- 9. The Institution shall obtain the recognition of the Dental Council of India and submit the copy of the same for records.
- 10. The admission procedure as enunciated by the Supreme Court of India, shall be followed.
- 11. The candidates admitted to I B.D.S. Degree Course should take up their examination as per the existing regulations of this University.
- 12. The college shall furnish a budget for every year of study and a separate development budget which will cover the expenses for the fulfillment of the requirements prescribed in the entire course of study.
- 13. The staff, student ratio prescribed by the Dental Council of India shall be followed.
- 14. The college shall abide by any other condition which the University may consider necessary and impose from time to time.
- 15. The sanctioned strength for the B.D.S. Degree course is 100 (One Hundred) for the academic year 2011-2012. The maximum number of students that may be admitted to the course shall not exceed the sanctioned strength.
- 16. Hostel accommodation shall be made available for the students.
- 17. Required furniture shall be provided.
- 18. Furnishing of false information to the University any matter or suppression of facts while furnishing information to the University or violation of any of the statutes, Ordinances, Regulations, Rules, Instructions or conditions of affiliation shall result in withdrawal of the affiliation of the college.
- 19. The college should furnish all the teaching and other staff details with qualification, experience, date of joining etc.,

- 20. The staff pattern with prescribed qualification by the University as well as the Dental Council of India should be followed.
- 21. The course should be conducted in accordance with the regulation and syllabi approved by this University and Dental Council of India.
- 22. The facilities should be made available for conducting University Examination.
- 23. During the University Examination, the Question papers will be sent through Internet for which the following equipments have to be purchased and kept ready by the institutions.
