Sir,

Kindly refer to this Ministry's letter of even no. dated 27.6.2005 on the above subject.

2. In connection with the renewal of Central Government Permission for 3rd year BDS Course in K.S.R. Institute of Dental Science & Research, Thokkavadi, Tiruchengode, Dist.: Namakkal, Tamil Nadu, for the academic session 2006-2007, I am desired to say that Dental Council of India (DCI), through their letter dated 27.6.2006, recommended for not renewing the permission for 3rd year BDS Course in the said dental college on account of certain deficiencies. The Central Government advised the college authorities to furnish their Compliance Report directly to DCI, vide this Ministry's letter dated 27.6.2006. Through their letter dated 1.7.2006, the college authorities indicated that they had submitted their Compliance Report to DCI.

After consideration of the Compliance Reports submitted by the college authorities, DCI, vide their letter dated 10.7.2006, recommended to renew the Central Government permission for year BDS Course at K.S.R. Institute of Dental Science & Research, Thokkavadi, Tiruchengode, Dist.: Namakkal, Tamil Nadu, for the academic session 2006-2007.

- 3. After due consideration of the above recommendation of DCI, a Special Inspection Team (SIT) comprising of Dr. Ritu Duggal, Addl. Proffessor, and Dr. Veena Jain, Associate Professor, Dental Department, All India Institute of Medical Sciences, New Delhi, was constituted by the Central Government for verification of the infrastructure and facilities in K.S.R. Institute of Dental Science & Research, Thokkavadi, Tiruchengode, Dist.: Namakkal, Tamil Nadu. The SIT inspected the college on 17-18 August, 2006 and submitted its Joint Inspection Report (JIR). On perusal of the JIR in this Ministry, it was observed that:
 - (1) There was a deficiency of 3 Dental Chairs.(2) Some faculty members were absent on the day of inspection.

(2) Some faculty members were a(3) Lack of OPD attendance.

4. The above facts were considered by the Central Government and decided to renew its permission for 3rd year BDS Course with reduced admission capacity, i.e. 40, for the academic session 2006-2007.

- 5. This permission is valid for only one year and for admitting only one batch of <u>40</u> students in BDS Course in K.S.R. Institute of Dental Science & Research, Thokkavadi, Tiruchengode, Dist.: Namakkal, Tamil Nadu, during 2006-2007. The next batch of students should be admitted only after renewal of Central Government Permission for 4th year BDS Course in the dental college.
- 6. Admissions made in violation of the above stipulations will attract the provisions of Section 10B of the Dentists Act, 1948 (16 of 1948).
