ORDER:-

In the Government Order first read above, the Government have taken a policy decision to grant permission to Private Trusts running Dental Colleges to have tie-up arrangements with the Government Hospitals subject to the following conditions.

- (a) The students shall be deputed in small batches without affecting the normal functioning of the Government Hospitals.
- (b) The Trusts shall also take action to construct their own hospitals within a period of three years and they shall give an undertaking to this effect.
- (c) The College shall pay a fee of Rs.2000/- (Rupees two thousand only) p.a. per student.

2. The Principal, K.S.R. Institute of Dental Science and Research, K.S.R. Kalvi Nagar, Thokkavadi P.O., Tiruchengode, Namakkal District has requested permission to avail clinical training for imparting training for 60 BDS students for three days in a week for ten months for a period of three years at the Government Head Quarters Hospital, Tiruchengode from the year 2010-11. The Director of Medical and Rural Health Services has forwarded the representation of the K.S.R. Institute of Dental Science and Research, Tiruchengode and the feasibility report submitted by the Joint Director of Health Services, Namakkal and requested to issue suitable orders on the request of K.S.R. Institute of Dental Science and Research to

have tie up arrangements with Government Headquarters Hospital, Tiruchengode for training their BDS students.

3. The Government have examined the request of the Principal, K.S.R. Institute of Dental Science and Research, K.S.R. Kalvi Nagar, Thokkavadi Post, Tiruchengode, Namakkal District based on the recommendations of the Director of Medical and Rural Health Services and permit the Principal, K.S.R. Institute of Dental Science and Research, K.S.R. Kalvi Nagar, Thokkavadi post, Tiruchengode, Namakkal District to have tie up arrangement with the Government Headquarters Hospital, Tiruchengode for their 60 BDS Students for 3 days in a week for 10 months in a year for a period of three years from the academic year 2010-11 subject to the conditions that the students shall be deputed in small batches without affecting the normal functions of the Government Hospital and the College shall pay a fee of Rs.2000/- (Rupees two thousand only) p.a. per student.

5. The Director of Medical and Rural Health Services is directed to take necessary action accordingly.
