ORDER:

The Principal, **K.S.R. Institute of Dental Science and Research, Tiruchengode** had applied to this University to issue Letter of Consent of Affiliation by producing the Essentiality Certificate issued by the State Government of Tamil Nadu. The inspection commission inspected the institution on 14.05.2010 and 27.07.2010. Based on the inspection report and Essentiality Certificate issued by the State Government of Tamil Nadu, the Letter of Consent of Affiliation was issued vide this University's letter No.Affln.IV(2)/13333/ 2010, dated 22.06.2010, 30.06.2010 and 30.07.2010. for the following specialities.

1. Periodontics – 3 seats
2. Oral and Maxillofacial Surgery – 3 seats
3. Conservative Dentistry and Endodontics – 3 seats
4. Prosthodontics and Crown & Bridge – 3 seats
5. Oral Pathology and Microbiology – 3 seats
6. Orthodontics and Dentofacial Orthopaedics – 3 seats
7. Pedodontics and Preventive Dentistry – 3 seats
8. Oral Medicine and Radiology – 3 seats

The Principal, **K.S.R. Institute of Dental Science and Research, Tiruchengode** in his letter No. 172/KSRIDS&R/2013, dated 10.04.2013 has enclosed a copy of the formal permission conveyed by the Central Government in the letter No. V.12017/33/2010-DE, dated 28.03.2013 in the specialities of Oral Medicine and Radiology – 3 seats and Conservative Dentistry and Endodontics – 3 seats from the academic year 2013-14 at K.S.R. Institute of Dental Science and Research, Tiruchengode.

Based on the proposal, this University has constituted two inspection teams to verify and report on the available infrastructural, teaching staff and other facilities at K.S.R. Institute of Dental Science and Research, Tiruchengode to decide for the grant of Provisional Affiliation for starting the above said two specialities in M.D.S. Degree Course. The inspection commissions have conducted inspection and submitted their reports to this University.

The inspection team conducted inspection in the Department of Oral Medicine & Radiology has pointed out the deficiency that the tie-up facility with the Government Headquarters Hospital, Tiruchengode has been expired from the academic year 2013-2014.

In the reference 10th cited, the Principal has submitted the feasibility certificate with proposal for tie-up submitted to the State Government of Tamil Nadu and stated that necessary Government Order to be submitted shortly.

In the reference 12th cited, the Principal of the institution has submitted the renewal permission for the tie-up with Government Hospital, Tiruchengode for a period of five years from the academic year 2013-2014. Accordingly, the deficiencies pointed out by the inspection team has been now fulfilled.

In pursuance to the permission granted by the Government of India, New Delhi and based on the reports of the inspection commission, this University grants Provisional Affiliation to K.S.R. Institute of Dental Science and Research, Tiruchengode for starting M.D.S. Degree Course in the following specialities with the annual intake noted against each from the academic year 2013-2014, subject to the approval of Governing Council and subject to the conditions mentioned in the Annexure.

- (i) Oral Medicine and Radiology – 3 seats
- (ii) Conservative Dentistry and Endodontics – 3 seats

As per the DCI norms, provide 50% of the seats for counseling under the single window system of the Government and the remaining 50% to be admitted by the management of the institution on the basis of merit test.

The same should be followed without any deviation.

ANNEXURE

The Provisional Affiliation is granted subject to the following conditions.

1. The admission procedure as laid down in G.O. (Ms) No.13, Health & Family Welfare (MCA1) Department, dated 22.01.2013 should be followed strictly. The seats available in MDS Degree Course shall be filled up as per orders in force. The Management shall follow a transparent and reasonable method of administration for the Management quota as per order in force.
2. The candidates should be admitted before the cut off date and they will be registered to take up their I year Examination as per existing regulations.
3. There shall not be any admission after the cut of date.
4. The conditions that may be prescribed by Dental Council of India, New Delhi shall be fulfilled and the rules and regulations of the Dental Council of India shall be followed strictly.
5. The Trust should obtained the renewal permission from the Government of India year after year and forward the same to the University. The next batch of students in M.D.S. Degree Course in the said specialities for the academic year 2014-2015 will be made only after renewal of permission by the Central Government.
6. The candidates admitted will take up their I MDS examination as per the existing regulation of this University.
7. The Trust and its college shall abide by the provisions of the Tamil Nadu Dr.M.G.R. Medical University, Chennai, Act, 1987 (Tamil Nadu Act 37 of 1987) and by the Statutes, Ordinances, Regulations and Rules of the Tamil Nadu Dr. M.G.R. Medical University applicable to the Dental Colleges framed from time to time.
8. The college should agree for the inspection by the Tamil Nadu Dr.M.G.R. Medical University at any time according to the Statutes, Ordinances, Regulations and Rules for Dental College framed time to time.
9. The said Trust and Dental College shall abide by the Provisions of the Statutes, Ordinances, Regulations and Rules framed by the Tamil Nadu Dr.M.G.R. Medical University on matters of Syllabus, Examinations, Code of conduct, extracurricular activities, etc. according to the Statutes, Ordinances, Regulations and Rules of the Tamil Nadu Dr.M.G.R. Medical University framed from time to time.
10. Only qualified staff shall be appointed to handle the classes in the MDS Degree Course.

11. No unqualified staff shall be appointed.
12. Only eligible candidates according to the regulations of this University shall be admitted to the I M.D.S. Degree Course.
13. There shall not be any financial commitment either to the University or to the Government.
14. Hostel accommodation shall be made available for the students both Male and Female.
15. Required furniture shall be provided wherever they are necessary.
16. Furnishing of false information to the University on any matter or suppression of facts while furnishing information to the University or violation of any of the Statutes, Ordinances, Regulations, Rules, Instructions or conditions of affiliation shall result in withdrawal of the affiliation of the course.
17. The College shall furnish a "Utilization Certificate" to the University stating that the interest accrued on the Security Deposit has been utilised towards maintenance of the Dental College.
18. The College shall furnish a Budget for each year of study and a separate development budget which will cover the expenses for the fulfillment of the requirements prescribed in the second, third and fourth year of the course of study.
19. After fulfilling all the conditions, required to be fulfilled by the College under the Tamil Nadu Dr.M.G.R. Medical University by the time only 6 months period is left for the I year MDS Degree Course of study, the Institution shall apply to this University for the grant of Continuance of Provisional Affiliation for the 2nd year MDS Degree Course of study.
20. The staff, student ratio prescribed by the Dental Council of India shall be followed.
21. Any other conditions which the University considers necessary to impose from time to time.
22. During the University Examination, the Question papers will be sent through Internet for which the following equipments have to be purchased and kept ready by the institutions.
