## ORDER:-

- i. the students shall be deputed in small batches without detrimental to the normal functioning of the Hospital.
- ii. The College shall pay the fees prescribed in as per G.O (D) No: 648, Health and Family Welfare Dept, Dated: 02.06.2009 for imparting special training.
- 3. The Director of Medical and Rural Health Services is directed to take necessary action accordingly.
